Murphy, a part-time attorney with the law firm, praised his employer with being "very supportive of my service in the Army National Guard – especially during my current deployment to Quatar in support of Operation Enduring Freedom." The Guardsman also noted in his nomination narrative that "my direct supervisor, Anthony H Ogozalek, Jr. Esq. has not only been supportive of my Citizen Soldier status, but he has also worked countless pro bono hours for the Veterans of Foreign Wars Post 3020 as an attorney helping out the Post and its veterans members."
